TERMS & CONDITIONS

The Foster Caretaker acknowledges receipt of cats/kittens from Kindred Kitties Ltd., and in accepting these cats, is entrusted with the care, custody and possession as outlined herein. Foster Caretaker shall ensure the cats receive good care, including appropriate shelter, food, water, medication, grooming, and training as needed. Kindred Kitties will provide Foster Caretaker with necessary equipment, food, medication and supplies, as required.

Once foster cats/kittens are deemed "adoptable" the Foster Caregiver is required to bring foster cats/kittens to Adoption Events regularly.

The cats shall remain the sole property of Kindred Kitties, and shall be returned to Kindred Kitties upon request. The Foster Caretaker does not have any right or authority to assume ownership of the foster cats, or to place them in other homes, surrender to other shelters, or place them with other individuals, without permission of Kindred Kitties Staff.

The Foster Caretaker agrees to closely observe the cats for signs of illness, and if a change in a cat's status is noted, will contact Kindred Kitties immediately to request instructions on steps that need to be taken. At the direction of Kindred Kitties Staff, the Foster Caretaker shall only seek veterinarian care for the cats at a veterinarian pre-approved and paid for by Kindred Kitties. In the unfortunate event that a cat becomes very ill and requires extensive medical treatment, the cat will be returned to Kindred Kitties.

Kindred Kitties reserves the right to inspect the premises in which the cats will be maintained, for the purpose of determining the suitability of those premises for the care and maintenance of the animal(s).

Kindred Kitties Ltd. does not assume liability for any injuries or expenses that may be incurred by volunteers, visitors or family members, whether caused by an animal or other source. By signing this agreement, the Foster Caretaker agrees to defend, indemnify and hold Kindred Kitties Ltd., its volunteers, its supporters and its cat harmless from any direct or remote and consequential damages arising out of this foster care arrangement. I have read and agree to all terms and conditions outlined in this agreement. I will provide the cats/kittens with the kindest and best care possible.
